

## LICK or Treat Giveaway

### Official Rules

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

**Timing:** The LICK or Treat Giveaway (the “Sweepstakes”) begins at 12:00 a.m. Pacific Time (“PT”) on 10/05/15 and ends at 11:59 p.m. Pacific Time (“PT”) on 11/1/15 (“Promotion Period”). Sponsor’s computer is the official time-keeping device for the Sweepstakes.

**Sponsor:** Knock Knock LLC, 1635-B Electric Avenue, Venice, CA 90291 (“Sponsor”).

**Eligibility:** Sweepstakes is open and offered only to legal residents of the fifty (50) United States, including the District of Columbia, who are at least eighteen (18) years of age at the time of entry. Employees and their immediate families (parent, child, sibling or spouse) and/or household members and those of the Sponsor’s respective parent companies, subsidiaries, affiliates, distributors, sales representatives, advertising and promotional agencies, and any other persons or entities associated with this promotion are ineligible to enter or win. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and to Sponsor’s decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

**How to Enter:** There are three (3) ways to enter, as outlined below. You will need a free account with either Facebook, Instagram, or Twitter to participate.

- a. **Facebook:** During the Promotion Period, create or access your Facebook account using your smartphone and post a photo (“Photo”) of your dog. You must include hashtag #LickBook. You will receive one (1) entry into the Sweepstakes. In order for your Photo to be valid, your account must be public and the photo entry photo must be new. Photos dated prior to the Promotion Period will be disqualified.
- b. **Instagram:** During the Promotion Period, create or access your Instagram account using your smartphone and post a photo (“Photo”) of your dog. You must include @knockknockstuff and hashtag #LickBook. You will receive one (1) entry into the Sweepstakes. In order for your Photo to be valid, your account must be public and the photo entry photo must be new. Photos dated prior to the Promotion Period will be disqualified.
- c. **Twitter:** During the Promotion Period, create or access your Twitter account using your smartphone and post a photo (“Photo”) of your dog. You must include @knockknock and

hashtag #LickBook. You will receive one (1) entry into the Sweepstakes. In order for your Photo to be valid, your account must be public and the photo entry photo must be new. Photos dated prior to the Promotion Period will be disqualified.

**Photo Guidelines:**

- The Photo must be in a format acceptable for Facebook, Instagram or Twitter;
- The Photo must include @knockknockstuff on Instagram;
- The Photo must include @knockknock on Twitter; and
- The Photo description must contain the hashtag #LickBook.

**Content Restrictions:**

- The Photo must not contain material that violates or infringes another's rights, including but not limited to privacy, publicity or intellectual property rights, or that constitutes copyright infringement;
- The Submission must not disparage Sponsor or any other person or party affiliated with the Sweepstakes;
- The Photo must not contain brand names or trademarks, except for Sponsor's trademark for which entrant has a limited license to use for the sole purposes of creating and uploading a Photo into this Sweepstakes;
- The Photo must not contain images or artwork not created by entrant;

- The Photo must not contain material that is unlawful, in violation of or contrary to the laws or regulations in any state where the Photo is created.

Uploading a Photo constitutes entrant's consent to give Sponsor a royalty-free, irrevocable, perpetual, non-exclusive license to use, reproduce, modify, publish, create derivative works from, and display such submissions in whole or in part, on a worldwide basis, and to incorporate it into other works, in any form, media or technology now known or later developed, including for promotional or marketing purposes. Entrant must have permission from all individuals that appear in the Submission (if any) to use their name and likeness in the Submission and to grant the rights set forth herein. If requested, entrant must be able to provide such permissions in a form acceptable to Sponsor. If necessary, entrant will sign any necessary documentation that may be required for Sponsor or its designees to make use of the non-exclusive rights entrant is granting to use the Photo. Sponsor is not responsible for lost, late, incomplete, invalid, un-intelligible or misdirected Photos, which are disqualified. By entering the Sweepstakes, you consent that the Sponsor can reach-out to you for prize fulfillment purposes.

**Limit:** Three (3) entries per person per Entry Period. Attempts to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations, and logins, or any other methods, will void that entrant's entries and entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an

Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being the authorized account holder.

**Winner Selection.** On or around the dates listed above, Sponsor will select one (1) entry for the prize described below in a random drawing of all valid entries received. The potential winners will be notified on Facebook, Twitter, or Instagram (whichever method the entrant used to upload their Photo.) Sponsor will reply to each winners' Photo entry, asking them to send an email to [blog@knockknockstuff.com](mailto:blog@knockknockstuff.com) within two (2) days. Sponsor will reply to the potential winners' email address with instructions on how to verify their identity and claim his/her prize. Sponsor's decisions as to the administration and operation of the Sweepstakes and the selection of the potential winner is final and binding in all matters related to the Sweepstakes. Failure to respond to the initial verification contact within five (5) days of notification will result in disqualification.
