Official Rules

Timing: Nouveau Knock Knock Stuff Giveaway (the "Sweepstakes") begins at 12:00 a.m. Pacific Time ("PT") on 01/27/16 and ends at 11:59 p.m. Pacific Time ("PT") on 02/03/16 ("Promotion Period"). Sponsor's computer is the official time-keeping device for the Sweepstakes.
