Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Timing: The Say Something More™ Giveaway (the “Sweepstakes”) begins at 7:00 a.m. Pacific Time (“PT”) on 05/24/16 and ends at 11:59 p.m. Pacific Time (“PT”) on 05/31/16 (“Promotion Period”). Sponsor’s computer is the official time-keeping device for the Sweepstakes.

Sponsor: Knock Knock®, 1635-B Electric Avenue, Venice, CA 90291 (“Sponsor”).

Eligibility: Sweepstakes is open and offered only to legal residents of the fifty (50) United States, including the District of Columbia, who are at least eighteen (18) years of age at the time of entry. Employees and their immediate families (parent, child, sibling or spouse) and/or household members and those of the Sponsor’s respective parent companies, subsidiaries, affiliates, distributors, sales representatives, advertising and promotional agencies, and any other persons or entities associated with this promotion are ineligible to enter or win. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and to Sponsor’s decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

How to Enter: There are four (4) ways to enter, as outlined below.

- a. **Knock Knock Website Method:** During the Promotion Period, visit <http://knockknockstuff.com/product-category/see-all/>, and click on any individual product image to proceed to its product page. Then, follow the instructions to submit a product review—including Star rating (1-5), Title, and Review. You will need to provide your name and email address to leave a review. You will receive one (1) Sweepstakes entry for submitting a review. Limit five (5) entries per Promotion Period via the Knock Knock Website method.
- b. **Social Media Method:**
 - a. **Instagram:** During the Promotion Period, create or access your free Instagram account using your smartphone and post a photo (“Photo”) of any Knock Knock product. You must include @knockknock and #SaySomethingMore in your caption. You will receive one (1) Sweepstakes entry for posting on Instagram.
 - b. **Facebook:** During the Promotion Period, create or access your free Facebook account and post a photo (“Photo”) of any Knock Knock product. You must include @knockknock and #SaySomethingMore in your caption. You will receive one (1) Sweepstakes entry for posting on Facebook.
 - c. **Twitter:** During the Promotion Period, create or access your free Twitter and post a photo (“Photo”) of any Knock Knock product. You must include @knockknock and #SaySomethingMore in your caption. You will receive one (1) Sweepstakes entry per for posting on Twitter.
 - d. Limit three (3) entries per Promotion Period via the Social Media method.

Photo Guidelines:

- In order for your Photo to be valid, your account must be public and the post must be new. Photo posts dated prior to the Promotion Period will be disqualified.
- The Photo must be in a format acceptable for Instagram, Facebook, and/or Twitter.
- The Photo caption must include @knockknock and #SaySomethingMore.

Content Restrictions:

- The Photo must not contain material that violates or infringes another's rights, including but not limited to privacy, publicity or intellectual property rights, or that constitutes copyright infringement;
- The Submission must not disparage Sponsor or any other person or party affiliated with the Sweepstakes;

Uploading a Photo constitutes entrant's consent to give Sponsor a royalty-free, irrevocable, perpetual, non-exclusive license to use, reproduce, modify, publish, create derivative works from, and display such submissions in whole or in part, on a worldwide basis, and to incorporate it into other works, in any form, media or technology now known or later developed, including for promotional or marketing purposes. Entrant must have permission from all individuals that appear in the Submission (if any) to use their name and likeness in the Submission and to grant the rights set forth herein. If requested, entrant must be able to provide such permissions in a form acceptable to Sponsor. If necessary, entrant will sign any necessary documentation that may be required for Sponsor or its designees to make use of the non-exclusive rights entrant is granting to use the Photo. Sponsor is not responsible for lost, late, incomplete, invalid, un-intelligible or misdirected Photos, which are disqualified. Approximate retail value of prize package is ("ARV"): \$251.96. Odds of winning a prize depend on the number of eligible entries received during the Promotion Period.
