Official Rules

Timing: The It's Summer! Giveaway (the "Sweepstakes") begins at 12:00 a.m. Pacific Time ("PT") on 07/19/16 and ends at 11:59 p.m. Pacific Time ("PT") on 08/02/16 ("Promotion Period"). Sponsor's computer is the official time-keeping device for the Sweepstakes.
